


Business Products and Services Deals for January 2026

There were 265 completed U.S. private equity deals in the Business Products & Services sector during the month of January. The number of deal transactions were approximately equal to December's deal count. There was a 35% decline in the number of Business Products & Services deals compared to January 2025.

The rail operating lease portfolio of Wells Fargo was acquired by Joint Venture (Brookfield Infrastructure Partners/ GATX), via its financial sponsor Brookfield Infrastructure Partners, through an LBO \$4.4 billion LBO on January 1, 2026.
