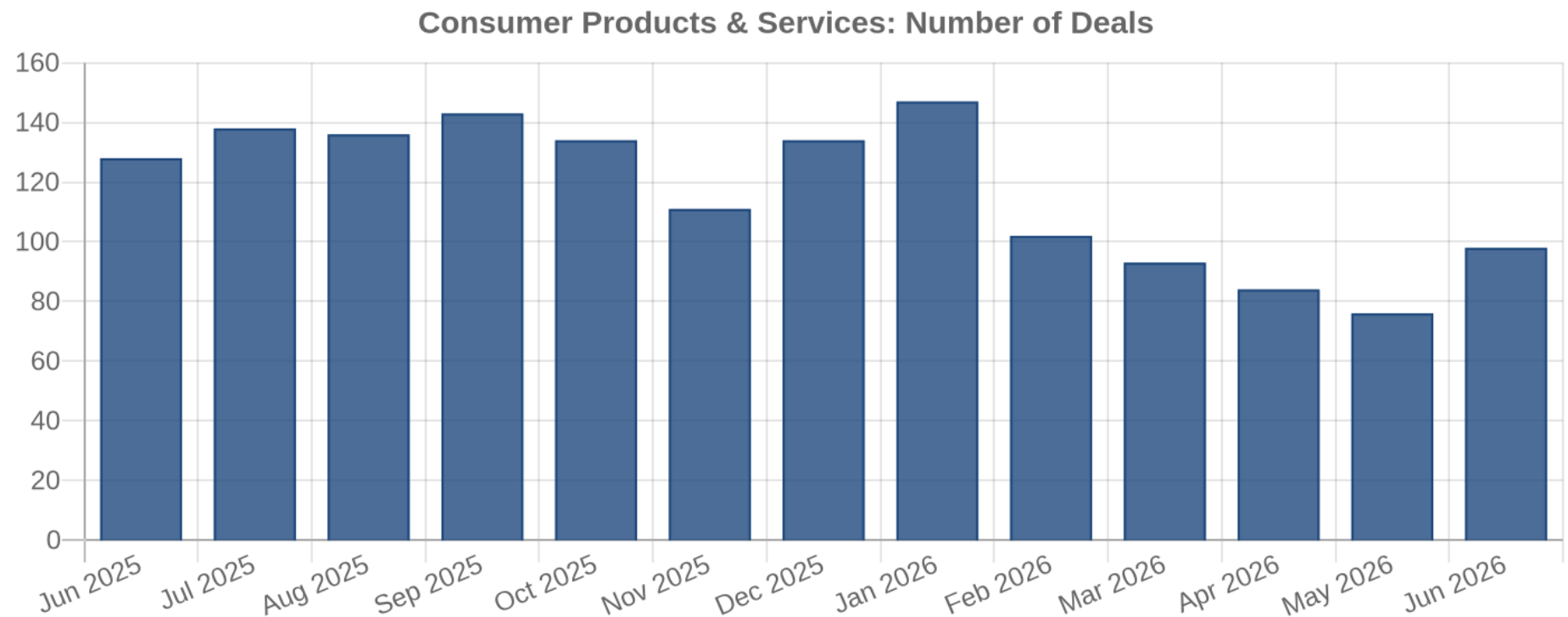


Consumer Products and Services Deals for June 2026

There were 98 completed U.S. private equity deals in the Consumer Products & Services sector during the month of June. The number of deal transactions increased 28.9% when compared to May's deal count. There was a 23.4% decline in the number of Consumer Products & Services deals compared to June 2025.
