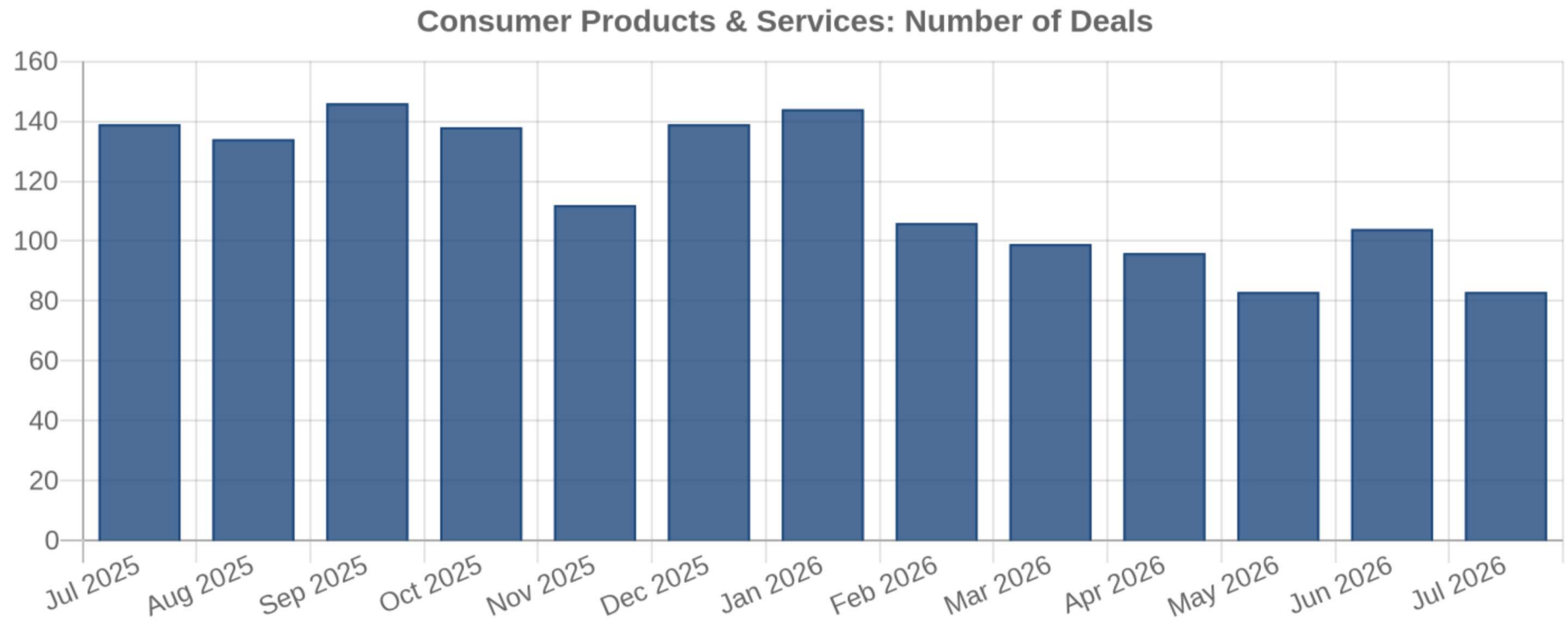


Consumer Products and Services Deals for July 2026

There were 83 completed U.S. private equity deals in the Consumer Products & Services sector during the month of July. The number of deal transactions decreased 20.2% when compared to June's deal count. There was a 40.3% decline in the number of Consumer Products & Services deals compared to July 2025.
